## Ticket Sales:

Online registration is due **Friday**, **February 8**<sup>th</sup>, **2019**. All students must register online at <u>www.reverepep.org</u>. Registration submitted after Friday, February 8<sup>th</sup>, 2019 will be placed on a waiting list and will only be processed if space permits.

- Only Graduation-Eligible 8<sup>th</sup> Graders may participate. Eligibility is based on the final first semester grades from the student's school: no more than two (2) fails, no more than two (2) "U"s in Work Habits or no more than two (2) "U"s in Cooperation. Students may not have more than 10 unexcused absences and/or tardies. The student needs to be in good standing at their school (no outstanding fines, un-served detentions). Students in violation of the school's behavior expectations on campus during the school year are not allowed to participate on this trip. Ticket is good only for Disneyland that day and may not be used for any other day. P.E.P. is not responsible for ineligible students at Disneyland or their transportation to or from the park. P.E.P. has the right to refuse participation for this event to any individual for any reason.
- Tickets are \$150.00 each. This pays for transportation from school and back and entrance into Disneyland only. You should bring extra money for dinner/snacks (\$20 \$25 is recommended). Payment for tickets should be made online. Donations in any amount will gladly be accepted to help subsidize tickets for students requesting scholarships. Tickets are only available for purchase through Friday, February 8<sup>th</sup>. There are absolutely no refunds Please make sure your child is eligible (grades, discipline, and attendance) before submitting application with payment. Registration submitted after Friday, February 8<sup>th</sup> will be placed on a waiting list and will only be processed if space permits.
- Scholarships (full and partial) are available based on need. If you would like financial assistance, the parent/guardian must submit a written request to Mr. Koretz, on or before **Wednesday**, **February 6<sup>th</sup>**, accompanied with a letter written by the student describing what they have accomplished, and a copy of the parent/guardian's previous year's tax return. Do NOT include any payment with the financial aid request at this time. All financial aid requests will be reviewed and students will be informed the following week. Therefore, late requests for financial assistance will only be reviewed if funds are available.
- You may **not** buy a ticket from another student **nor** sell your ticket to another student.
- The "Ticket Application" must be filled out online completely and submitted with payment. All emergency contact information and signatures must be completed in order for the application to be processed.
- All students and chaperones going to Disneyland must ride the bus both ways. Buses will be assigned by alphabetical order (last name) and will leave after dismissal (12:30 p.m.) from Revere. Tickets will be given to students as they exit the bus upon arrival. Students cannot leave anything on the bus while at Disneyland.
- Upon returning to the school from Disneyland, students are responsible for their own transportation home. Buses are scheduled to return to the school around midnight. Please make sure student has a ride home!
- Dress Code: Disneyland's dress code will be enforced. You must comply with the dress code in order to board the buses and attend the event. Students not in compliance will not be allowed into Disneyland and will not be given a refund. This is up to the discretion of Disneyland employees. Please bring a sweater or jacket as it will be cool in the evening.
- No one may leave the park at anytime before the end of the evening. We expect all students to behave appropriately while on this special trip. No alcohol, drugs or weapons are permitted on the bus or in the park. Any violation of Disneyland rules will result with appropriate consequences. You may be required to remain in the company of a chaperone for behavioral violations or even picked up from the park by your parent/guardian if it is deemed necessary. Any student that is detained by Disneyland security MUST be picked up by a parent or guardian and will NOT be allowed to ride the bus back to school. All students are subject to a protective search prior to loading the bus and/or entering the park. District and school rules apply.
- Students must be at the bus by **11:00 p.m**. as buses will depart at this time. Students need to find their bus and board promptly. Students must return on the same bus # in which they came. If a student does not return to the bus and cannot be contacted, parent or guardian will be responsible for child and will need to go to Disneyland to pick up student, as buses are scheduled to leave at 11:00pm promptly.
- Students will not be with a chaperone while at Disneyland. However, if they need assistance at the park, in addition to park employees, PEP chaperones will be stationed at the Carnation Plaza on Main Street in Disneyland throughout the day.
